MINUTES OF SEPTEMBER 13, 2007

The one hundred and sixty second meeting of the Florida Transportation Commission was held Thursday, September 13, 2007 at the Crowne Plaza, 200 E. Gregory Street, Pensacola, Florida Chairman Jim Holton called the meeting to order at 8:30 a.m.

CHAIRMAN'S REPORT

MINUTES

Minutes of the May 24, 2007 Commission Meeting were approved.

Chairman Holton reported on the following:

- The Commission welcomed new Commissioner Bart Pullum. Commissioner Pullum was appointed to the Commission this summer to fill the position that Commissioner Earl Durden vacated.

- Commissioner Marchena spoke at the FICE meeting and also attended the TEAMFL
 meeting this week in Ft. Myers, where he gave a briefing on the new oversight
 responsibilities of the Commission.
- The next Florida Transportation Commission meeting is scheduled for October 9, 2007 in Ft. Lauderdale.
- Election of Florida Transportation Commission Officers will be held at the October 9
 meeting. Commissioner Lanahan is heading up the Nominating Committee and two
 meetings have been noticed to discuss nominations.
- Florida Statutes require that candidates for membership on the Center for Urban Transportation Research (CUTR) Advisory Board be submitted to the Commission for

approval. CUTR is seeking approval for the appointment of Ysela Llort, Assistant County Manager for Miami Dade and former FDOT Assistant Secretary. A motion was made by Commissioner Criser and seconded by Commissioner Marchena to approve the appointment. The motion carried unanimously.

The Honorable John Fogg, Mayor of Pensacola spoke briefly and welcomed everyone to Pensacola.

FDOT FISCAL YEAR 2006/2007 PERFORMANCE AND PRODUCTION REVIEW

David Tassinari, Manager of Finance & Performance Monitoring, presented the Annual Performance and Production Review of the Department of Transportation for FY 2006/07. The Department met 14 of 21 primary performance measures in FY 2006/07.

The Department's performance improved from last year and the Department continues to implement process improvements.
