MINUTES OF: November 30, 2015 MEETING NUMBER: 212

The two hundred and twelfth meeting of the Florida Transportation Commission was held on November 30, 2015 at the Hyatt Regency Jacksonville Riverfront, 225 East Coastline Drive, Jacksonville, Florida.

ATTENDANCE:

Members in attendance were: Chairman Trumbull, Commissioners Browning, Ellington, Ferré, Howse, Kigel, and Wright. Commissioners Frazier and Sebesta were unable to attend due to scheduling conflicts.

CALL TO ORDER AND CHAIRMAN'S OPENING REMARKS:

Chairman Trumbull called the meeting to order at 1:30 P.M. Chairman Trumbull announced that this meeting is Bob Romig's final FTC meeting. Chairman Trumbull thanked Bob for his service to the FTC and to the citizens of the State of Florida. Bob is officially retiring from State government on December 4.

Commissioners Ellington and Howse provided comments on the efforts of the Subcommittee dealing with the Business Development Initiative and permitting issues.

FLORIDA TRANSPORTATION COMMISSION REVIEW OF DRAFT FLORIDA TRANSPORTATION PLAN POLICY ELEMENT:

Chairman Trumbull provided opening comments for the FTC review of the FTP noting that the Florida Transportation Plan is <u>THE</u> transportation plan for all of Florida; including: Florida Department of Transportation, 27 Metropolitan Planning Organizations, Local Governments, Modal Partners, and Other State Agencies.

The FTC has the statutory role of reviewing the Florida Transportation Plan to ensure it was developed in accordance with state and federal laws and departmental policies.

It is the overarching framework which guides Florida's transportation future. It provides direction to the FDOT and all organizations that are involved in planning and managing our transportation system.

Commissioner Ken Wright is the Commission's representative on the FTP Steering Committee and also chaired the SIS Sub-committee. Rich Biter provided opening remarks followed by Commissioner Wright.
