
*Transportation performance and productivity standards* Six areas for performance evaluation

Reduce the total number of measures in favor of simple meaningful measures and objectives Eliminate secondary measures in favor of focusing on measures that move the needle in each category.




Where possible, ensure alignment with the FDOT's Vital Few and FTC Area for Performance Evaluation/goal area.
