Survey Results

Disadvantaged Business Enterprise and Minority Business Programs

- As discussed, Small Business Initiative/Business Development Initiative should be added as a secondary measure.
- The Department should continue to focus on growing the industry thru these programs.

Finance and Administration

- As discussed, the measures exclusively focus on federal aid. This is a small portion of our resources.
- Preference is that we introduce primary measures that focus on the Department's overall budget for WP and Operating.
- How well are we utilizing the budget/funds provided.

Safety of the current system

- As discussed, safety needs to have appropriate primary measures that focus on driving fatalities and serious injuries down to zero.
- We need to account for all modes.
- The Florida Highway Safety Plan should be reviewed as well as the Department's safety dashboard. These should be stretch goals.



Governor Ron DeSantis's Transportation Priorities






Workgroup objectives for setting goals

Preservation of current state highway system

Current FTC Primary Measures	Current FTC Secondary Measures
The percentage of bridge structures on the State Highway System having a condition rating of either excellent or good.	The number of bridge repair projects that were planned to be executed during the year compared with the number of projects actually executed during the year.
The percentage of bridge structures on the State Highway System with posted weight restrictions.	Percentage of Bridge Replacement Projects Executed Compared to the Number Planned.
The percentage of lane miles on the State Highway System having a Pavement Condition Rating of either excellent or good.	Percentage of Lane Miles Resurfaced Compared to the Number Planned.
Achieve a Maintenance Rating of at least 80 on the State Highway System.

Primary and Secondary Measures-Production

Current FTC Primary Measures	Current FTC Secondary Measures
The consultant contract dollars executed as a percentage of the original estimated amount.	The number of consultant contracts actually executed compared against the number of consultant contracts planned to be executed during the year.
The number of ROW projects certified compared to the number scheduled for certification.	The number of parcels acquired through negotiation compared with the number acquired through condemnation.
The construction contract dollars executed as a percentage of the original estimated amount.	Percent of parcels negotiated within 20% of the Department's initial offer.
The number of construction contracts actually executed compared against the number planned.	Of the condemned parcels acquired; the percentage of final judgments that were equal to or less than one-half of the range of contention between the Department and the landowner.
For all construction contracts completed during the year, the percentage of those contracts that were completed within 20% above the original contract time.	Land expenditures should account for no less than 75% of total ROW expenditures.
	The total final amount paid on completed construction contracts that was attributable to supplemental agreements that were avoidable (i.e., should have been foreseen).
